

## **BRIDGEPORT - 95 SYLVAN AVENUE**

**FROM MERRITT PARKWAY NORTH:** Take exit 49 South, (Route 25 and 8 connector). Proceed to exit 5 (Boston Avenue/North Avenue). At the end of the exit ramp bear right, which will put you onto Chopsey Hill Road. Proceed to the second traffic light. At the second traffic light turn right onto North Avenue/Route 1. Then turn right again at the first street on the right (Sylvan Avenue). Proceed straight ahead to the DMV.

**FROM MERRITT PARKWAY SOUTH:** Take exit 52, (Route 25 and 8 connector). Proceed to exit 5 (Boston Avenue/North Avenue). At the end of the exit ramp bear right, which will put you onto Chopsey Hill Road. Proceed to the second traffic light. At the second traffic light turn right onto North Avenue/Route 1. Then turn right again at the first street on the right (Sylvan Avenue). Proceed straight ahead to the DMV.

**FROM I-95 NORTH OR SOUTH:** Take exit 27A, (Route 25 and 8 connector). Proceed to exit 5 (Boston Avenue/North Avenue). Go straight to the end of the exit ramp (Do not bear right). At the end of the exit ramp turn left onto Chopsey Hill Road. At the next traffic light turn right onto North Avenue/Route 1. Then turn right again at the first street on the right (Sylvan Avenue). Proceed straight ahead to the DMV.

## **DANBURY - 2 LEE MAC AVENUE**

**FROM I-84 EAST:** Take exit 5. At the end of the ramp, go straight onto Down Street to the traffic light. At the light turn right onto Main Street. Stay on Main Street to the eighth traffic light (you will be facing the War Memorial Statue) and turn left onto South Street. Bear left at the second traffic light continuing on Route 53 South. At the next traffic light turn left onto Shelter Rock Road. Then turn left at the next traffic light onto Lee Mac Avenue. The DMV will be on the right.

**FROM I-84 WEST:** Take exit 8. Stay to the left and follow to the third traffic light. At the third traffic light, go straight onto Newtown Road (Route 6 West, towards Danbury). Travel approximately one and eight tenths miles and turn left onto Triangle Street. Follow to Lee Mac Avenue. (Triangle Street leads into Lee Mac Avenue.) The DMV will be on the left.

## **ENFIELD - 4 PEARSON WAY**

**FROM I-91 SOUTH:** Take exit 48, turn left off the exit onto Elm Street/Route 220. Continue on Elm Street to a fork in the road. Bear left at the fork staying on Route 220. At second traffic light, turn right onto George Washington Road. Turn left onto Pearson Way. The DMV is the second building on the right.

**FROM I-91 NORTH:** Take exit 48, turn right off the exit onto Elm Street/Route 220. Continue on Elm Street to a fork in the road. Bear left at the fork staying on Route 220. At second traffic light, turn right onto George

Washington Road. Turn left onto Pearson Way. The DMV is the second building on right.

**FROM ROUTE 5 NORTH:** Take a right onto Route 220 (Elm Street). Go under the I-91 overpass. Continue on Elm Street to fork in the road. Bear left at fork staying on Route 220. At the second traffic light, turn right onto George Washington Road. Turn left onto Pearson Way. The DMV is the second building on the right.

**FROM ROUTE 5 SOUTH:** Turn left onto Route 220 (Elm Street). Go under the I-91 overpass. Continue on Elm Street to fork in the road. Bear left at fork staying on Route 220. At second traffic light, turn right onto George Washington Road then left onto Pearson Way. The DMV is the second building on the right.

## **HAMDEN - 1985 STATE STREET**

**FROM I-91 NORTH:** Take exit 5. At the traffic light proceed straight on State Street. DMV is approximately three miles up on the right.

**FROM I-91 SOUTH:** Take exit 10. Take first exit off the ramp (exit 1). Turn right off the exit to the traffic light. At the traffic light, turn right onto State Street. DMV is approximately three miles up on the left.

**FROM ROUTE 15 NORTH:** Take exit 62 turn left onto Dixwell Avenue. Go three tenths of a mile to Route 5 (State Street). Turn right onto State Street. DMV is approximately three miles on the left.

**FROM ROUTE 15 SOUTH:** Take exit 63 (Bishop Street). Turn left at end of the ramp. Take a left at first traffic light (Bishop Street/Route 22). Take a right at second light (State Street/Route 5). DMV is 5 miles on the left.

## **NEW BRITAIN - 85 NORTH MOUNTAIN ROAD**

**FROM I-84 EAST:** Take exit 34 (Crooked Street). Turn left off the exit. At the next traffic light turn right onto Route 372 East. Travel one mile. Turn left onto North Mountain Road. The DMV is approximately one tenth of a mile up on the right.

**FROM I-84 WEST:** Take exit 33 (Route 372) then take exit 2. Turn right off the exit onto West Main Street. Travel about one and a half miles. Turn left onto North Mountain Road (just before Shaw's supermarket). The DMV is one tenth of a mile up on the right.

## **NORWALK - 540 MAIN AVENUE**

**FROM MERRITT PARKWAY NORTH:** Take exit 40B, Main Avenue, Route 7 North Danbury. Turn right at the end of the exit. The DMV is approximately one mile up on the right.

**FROM MERRITT PARKWAY SOUTH:** Take exit 40B, Route 7 North Danbury. Turn right off the exit. DMV is approximately one mile on the right.

**FROM I-95 NORTH OR SOUTH:** Take exit 15, Route 7 Danbury/Norwalk. At end of expressway, turn right. DMV is approximately one fourth of a mile straight ahead.

**FROM ROUTE 7 SOUTH (DANBURY):** At junction of Route 33 bear right staying on Route 7. DMV is approximately two miles on the left.

## **NORWICH - 173 SALEM TURNPIKE**

**FROM ROUTE 395 NORTH:** Take exit 80. Turn right off the exit onto Route 82. Go underneath the overpass and take your first right after the traffic light into the State of Connecticut Complex.

**FROM ROUTE 395 SOUTH:** Take exit 80. Turn right off the exit onto Route 82. Take the first right before the traffic light into the State of Connecticut Complex.

## **OLD SAYBROOK - 7 CUSTOM DRIVE**

**FROM I-95 NORTH:** Take exit 66. Turn left off the exit onto Route 166. DMV is one fourth of a mile on the left.

**FROM I-95 SOUTH:** Take exit 66. Turn right onto Route 166. DMV is one tenth of a mile on the left.

## **PUTNAM - 165 KENNEDY DRIVE**

**FROM I-84 EAST:** Take exit 69 (Route 74 East). At junction of Route 44, turn left. Follow Route 44 into Putnam. At first traffic light at intersection of Route 44 and Kennedy Drive, turn right. Immediately turn left into the municipal parking lot. DMV is in the small building in the corner of the parking lot.

**FROM ROUTE 395 NORTH OR SOUTH:** Take exit 95. At end of ramp, turn right onto Kennedy Drive. Just prior to first traffic light at intersection of Kennedy Drive and Route 44, turn right into the municipal parking lot. DMV is in the small building in the corner of the parking lot.

## **STAMFORD - 888 WASHINGTON BOULEVARD**

**FROM I-95 SOUTH:** Take exit 7. Turn right at the traffic light. At the next light, turn left onto Tressler Boulevard. Go approximately one fourth of a mile. DMV is in the Stamford Government Center on the sixth floor.

**FROM I-95 NORTH:** Take exit 7. Continue straight and over a bridge. At traffic light, turn left onto Washington Boulevard. DMV is in the Stamford Government Center on the sixth floor.

## **WATERBURY - 2210 THOMASTON AVENUE**

**FROM I-84 EAST AND WEST:** Take exit 20 to Route 8 North. Take Route 8 North to exit 36. Turn right onto Huntingdon Avenue. At the second light, turn left onto Thomaston Avenue. DMV is approximately two miles on the right.

**FROM ROUTE 8 NORTH:** Take exit 36. Turn right onto Huntingdon Avenue. At second light, turn left onto Thomaston Avenue. DMV is approximately two miles on the right.

**FROM ROUTE 8 SOUTH:** Take exit 37. Turn left at the end of exit. Turn right at stop sign onto Thomaston Avenue. DMV is approximately two miles on the left.

**WETHERSFIELD - 60 STATE STREET**

**FROM I-84 WEST:** Take exit 57 (I-91 South/Charter Oak Bridge/New York City/Route 15 South). Take exit 86 (I-91 South/New Haven/New York City) onto I-91 South. Follow I-91 South to exit 26 (Old Wethersfield). Turn right at end of exit. Follow signs to DMV.

**FROM I-84 EAST:** Take exit 52 onto I-91 South. Follow I-91 South to exit 26 (Old Wethersfield). Turn right off the exit. Follow signs to DMV.

**FROM I-91 SOUTH:** Take exit 26 (Old Wethersfield). Turn right off the exit. Follow signs to DMV.

**FROM I-91 NORTH:** Take exit 25-26 (Old Wethersfield). Take exit 26. Turn left at end of exit. Follow signs to DMV.

**WILLIMANTIC - 1557 WEST MAIN STREET**

**FROM ROUTE 66 EAST:** Follow Route 66 (Willimantic Road/Columbia Avenue). Turn left onto Route 32.

**FROM ROUTE 66 AND 32:** Follow Routes 66 and 32 through Willimantic center. Bear right, remaining on Route 32, which is Main Street. DMV is approximately one-fourth of a mile on the right.

**FROM ROUTE 32 SOUTH:** Follow Route 32 south. Continue past Route 6/66 overpass. DMV is one mile on the left.

**WINSTED (NORTHWEST) - 151 TORRINGTON ROAD**

**FROM ROUTE 44 EAST:** Follow Route 44 East through downtown Winsted. Turn right at the first traffic light after Saint James Episcopal Church. DMV is approximately two miles on the left.

**FROM ROUTE 44 WEST:** Follow Route 44 West into Winsted. Turn left at the first traffic light after McDonald's. DMV is approximately two miles on the left.

**FROM ROUTE 8 SOUTH:** Take exit 46 (Pine Woods Road). Turn right off the exit to a stop sign. Turn right at the stop sign. DMV is on the right.

**FROM ROUTE 8 NORTH:** Take exit 46 (Pine Woods Road). Turn left off the exit to a stop sign. Turn right. DMV is on the right.


